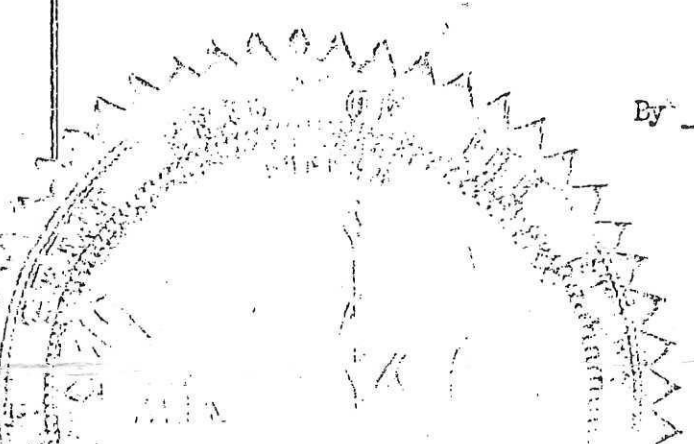
Therefore, and under Sections 71192 and 71194, Water Code, I further certify that the territory described in said Resolution has been duly incorporated according to the laws of this State under the name:

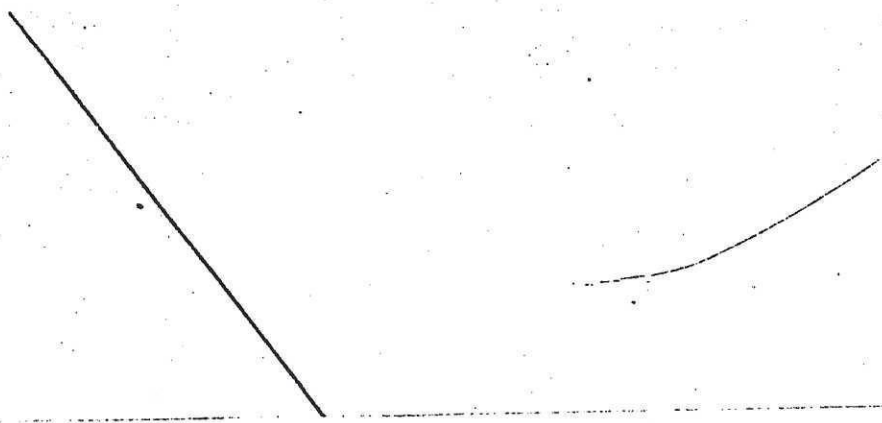
